



Admission Limits

All Saints CE First School's published admission number (PAN) is 12.
To comply with class size legislation there will be a maximum of 30 children in KS1 Classes.

Catchment Area

The catchment area of the school is the Parish of Leigh.

Admissions Criteria

If the number of applications for admission to the school exceeds the Published Admission Number (PAN), the following order of priority is used to allocate the available places. In accordance with legislation, children who have a statutory statement of special educational need, or Education, Health and Care Plan that names the school must be admitted. This will reduce the number of places available to other application Paragraph 1.6 of the code).

A Looked after children and previously looked after children

(That is "children who are looked after by a local authority in accordance with section 22 of the Children's act 1989 (b) and who are (a) looked after at the time an application is made and (b) in relation to whom the local authority has confirmed that the child will still be looked after at the time when the child will be admitted to school, **and** children who were looked after, but ceased to be so because they were adopted or became subject to a residence order or special guardianship order Paragraph 1.7 of the code)

B Residence in the catchment area of the school (i.e. the Parish of Leigh)

C Pupils, who at the time of the admission, have a sibling **in attendance** at the school.

(For admission purposes a sibling is a child who lives at the same address and who is brother/sister, half brother/sister (children who share one common parent), step brother/sister where two children are related by marriage. This definition also includes adopted or fostered children living at the same address).

D School being the nearest school to the child's home when measuring by the shortest road route to the Main School Gate.

(This may be used as a decider in a tiebreak situation. The Local Authority uses a Geographical Information System (GIS) to calculate home to school distances. The coordinates of an applicant's home address are determined and provided by the Local Land and Property Gazetteer (LLPG) and OS Address Point data.)

Admission of Reception Age Children

All pupils are admitted at the beginning of the school year following their fourth birthday.

Admissions Procedure

In response to a request for a place for a child at All Saints CE First School, Parents will be sent the following:

-

(a) Information containing the admission criteria and an application form to be returned to the school or directly to the LA.

(b) Early in the Summer term a letter will be sent by the LA offering a place at the school, or stating that no place is available.

Immediate admissions

When a pupil moves into the catchment area and is transferring from another school, it may be necessary to effect immediate admission. In this event, authority to admit is delegated to the Headteacher, providing a place is available.

Admissions

The headteacher is delegated to admit pupils following the agreed criteria or admissions at the start of the Nursery and Reception year.

Appeal

All applicants refused a place have a right of appeal to an independent appeal panel constituted and operated in accordance with the School Admission Appeals Code. Appellants should contact Staffordshire Local Authority to lodge an appeal. The appeals process is run in accordance with statutory processes and timescales set out in the School Admissions Appeals Code.

Deferred Entry to Reception Class

Parents may request that their child be admitted to Reception Class on a part-time basis, or that their child be admitted to school later in the same academic year until the child reaches compulsory school age (i.e. beginning of the term after the child's fifth birthday). The effect is that the place will be held for the child in Reception and is not available to be offered to any other child within the same academic year in which it has been offered.

Before deciding whether to defer their child's entry to school, parents should visit the school to clarify how we cater for the youngest children in Reception and how the needs of these children are met as they move up through the school.

Admission Outside of the Normal Age Group

Parents may seek to apply for their child's admission to school outside of their normal age group, for example if the child is exceptionally gifted and talented or has experienced problems such as ill health. In addition, the parents of summer born children may choose not to send their child to school until the September following their fifth birthday and may request that they are admitted outside of their normal age group to Reception rather than Year 1.

These parents will need to make an application alongside children applying at the normal age which should explain why it is in the child's best interest to be admitted outside of their normal age which may include information such as professional evidence as to why this is the case and why an exception should be made in the case of the child. A decision as to whether this is an appropriate course of action will be made by the Governing Body who will take into account the circumstances of the case and views of the headteacher. Parents do not have the right to insist that their child is admitted to a particular year group.

School Uniform

The school has a uniform and it is expected that all new pupils will wear this uniform –see the Uniform guidelines on the school website
